Approval of Agenda

Public Comment Zack Dalton discussed with council the Repository purchase request. Michelle Joy confirmed he was requesting a waiver of taxes. (ITEM 1) Denny Stiteler made a motion, seconded by Bart Carr to approve the sale of 2nd Ave Lot 44 of that property for Zack Dalton (Annabella Properties, LLC). Roll Call Vote Yes: Jason Landsbach, Jeff Magee, Dennis Stiteler, Kim Wagner, Roz Miller, Bart Carr, Michelle Joy. Jennifer Gasser confirmed taxes are being waived including 2020.

Approval of Minutes

Professional Reports:

Mayors Report: Mayor Wachter advised Castle Brook development off 351 has put in sidewalks.

Zoning Report: Dawna Pella advised the Valley Waste Variance Hearing was approved and they were issued their building permit. Dawna Pella reported on the house fire on Fairlane BLDV.

Roz Miller made a motion, seconded Jeff Magee to approve the Lindy Paving Bond Reduction number #1 in the amount of \$221,056.00 with the remaining bond amount total of zero. Solicitor Report: Shannon Steele advised she reviewed and advertised both the Firefighter and Tax Mill Ordinance. Shannon reported on a phone conversation she had with the team for the advancement on the second issuance on the bond and they are ready to move forward with the 1.2 Million Dollar bond. The debt service would be what it originally was supposed to be. This is on the Agenda to be voted on.

Public Works Report: Chad Crawford advised he met with the Conservation District to review Alley Hill and they will create a drainage plan for the borough. They will not have funding until possibly Aug 2021 and this project may get put off until the Summer of 2022, unless funding is freed up.

Planning Commission: Council discussed there was no changes from the prior vote with Planning Commission. Roz Miller reported there was discussion about it at the Planning Commission meeting and John Heyl discussed with the Farrelly's their subdivision application, and another plan proposed on Foxwood.

Council discussed the available Taps. Larry Lennon advised they will have to go through the DEP Approval process for the planning module for the Corrective Action Plan. Roz Miller requested Chad Crawford check the building for repairs.

- ITEM 11 Council discussed the requested penalty waiver EastWood Drive (Ramada Inn) 5%. - ITEM 12 Jason Landsbach made a motion, seconded by Jeff Magee to adopt the new MDIA Fees. - ITEM 14 Debbie Ahern advised the second bond would be 1.2 million, the payment of both bonds will be \$100,000.00 and they are looking to have this completed possibly by the January 19th meeting, if not it would be February. Bart Carr made a motion, seconded by Kim Wagner to advance the 2nd issue of bond to finish it up from the beginning of the year. Roll Call Vote Yes: Jason Landsbach, Jeff Magee, Dennis Stiteler, Kim Wagner, Roz Miller, Bart Carr, Michelle Joy. All in favor, motion carried.

New Business Discussion:

Council discussed a request for approval for Duck and Waterfowl hunting at the Wetlands on Route 168. Council discussed the State Law https://www.legis.state.pa.us section 2508 title 34 Game. Roz Miller requested the Borough's website updated to reflect there is no hunting at the park or wetlands and site the state law. Roz

Michelle Joy advised to put together any questions for the police department.

Council requested the paper shredder bin removed, as it is not being emptied.

Roz Miller advised she spoke with Chad Crawford to build an outside library.
