The Act 32 Earned Income Tax Monthly Report was reviewed by council.

Streets & Roads/Buildings & Equipment:

Due to the absence of the road master, no report was given.

Councilman Bart Carr is looking into ceiling fans for the road garage.

Public Relations:

Roz Miller made a motion seconded by Dennis Stiteler to approve the renewal for pet control by the Beaver County Humane Society in the amount of \$265.00 per month for the 2019 year. All in favor, motion carried.

Parks & Recreation:

The Park's Covered Bridge reinforcement is still ongoing. LSSE is working on it.

Planning Commission:

Municipal Authority:

Shannon Steele reported on the Municipal Authority meeting on November 19th and asked for a motion to advertise for an ordinance to collect on delinquent sewer accounts. Dawna Pella, Zoning/Code Enforcement Officer gave her report.

Solicitor:

Solicitor Steele gave her report under the Municipal Authority.

Roz Miller made a motion seconded by Bart Carr to approve a public statement, written by the borough solicitor, that will be recited by Jason Landsbach at the December 4th Mt. Airy / PA Gaming Control Board Hearing. All in favor, motion carried.

Engineer:

Engineer Lennon gave his report.

Engineer Lennon updated council that Brady's Run Sanitary Authority has removed the fence post and the storm sewer was repaired at Patricia Drive.

Michelle Joy made a motion seconded by Jeff Magee to reduce the bond reduction request for the Dollar General final land development and subdivision plan in the amount of \$33,692.50. All in favor, motion carried.

Mayor:

The crosswalk intersection in Koppel was discussed. Michelle Joy made a motion seconded by Roz Miller for Ms. Candy Braniff to research for a subcontractor to rebuild the crosswalk to state regulations at the intersection of Route 18 and SR 351.

At 9:55 President Landsbach suspended the regular meeting for an executive session to discuss personnel issues. At 11:00 the regular meeting resumed.
